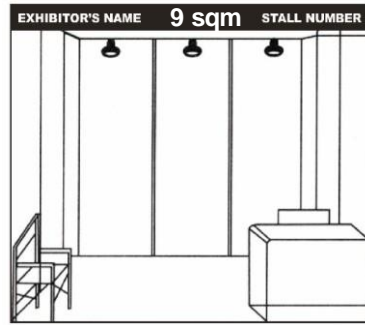

### APPLICATION FOR PARTICIPATION:

All applications for participation should be made in the prescribed form. Submission of this form will confirm participation and acceptance of the terms and conditions. EETF reserve the right to accept or refuse any application without assigning any reason for the same.

**ALLOTMENT OF BOOTH :** Location will be allocated as per the defined guideline of EETF . Allocation of the stall will be Subject to the products or services offered by participants in the **GREAT INDIA TEXTILE SHOW VARANASI** Hangers / Halls are designed on that basis only and allocation will be done within that Hanger / Hall only.

EETF will try to meet the exhibitors' preference to the extent possible but within defined dome only. However, EETF reserves the right to change the location allotted to the exhibitor at any time prior to commencing of exhibition. The decision of EETF will be final and binding to the exhibitors.

**TERMS OF PAYMENT:** The contract form shall be accompanied by 100% payment by Demand Draft /Cheque drawn in favour of EETF, payable at Mumbai . In case of payment through cheque/DD, the confirmation of booked stall will be subject to realization of cheque/DD. If cheque/DD gets dishonored, EETF reserves right to cancel booking and allot the same stall to other party. Once the form is filled up and submitted to us, party has to abide by the terms & conditions of EETF. Once booking is confirmed, party is contractually bound to make payment, though it does not occupy booked stall/s. In any case, no refund of paid amount under any circumstance.

**CANCELLATION POLICY : NO REFUND & NO CANCELLATION OF STALL UNDER ANY CIRCUMSTANCES. Organiser is not responsible/ liable for any refund in case of Rain, Flood, Earthquake, Riots or any other such incidences**

Exhibitors are not permitted to display / arrange their products in walk way area, neither on the barricading and also not permitted to sublet their allotted location / stall in part/full to a third party, with or without charge, EETF have reserves right to change the venue, date, and timing of the exhibition without giving prior notice. In such cases, any exhibitors are requested to follow the rules.

**SHOWCASING AREA:** Exhibitors are not permitted to make any noise in the SHOWCASING hanger / hall which disturbs the other stalls in the same hanger / hall . Stalls allocating in SHOWCASING area, stall holders are not permitted to sell any goods or products from their stalls. Any stall holders caught doing the same will be punished on the spot. EETF reserves full right to terminate their stall and no refund will be given in any such case.

**BASIC STRUCTURE:**The basic structure & mentioned items of each stall will be provided by the organizer. Non-utilization of part or full facility of basic structure provided will not entitle an exhibitor for any refund.

**ADDITIONAL ITEMS:** Any additional requirement by the exhibitors would be provided, if possible, at extra cost. Once the stall is allocated to the exhibitors they are eligible to demand extra items at least 30 days prior to the exhibition.

The details of rates of extra items are specified and requested to furnish such details in the given form at the time of booking dates are mentioned.

**BOTH / RAW SPACE CANCELLATION:** In case of exhibitors want to cancel their allotted booth **NO REFUND WILL BE MADE UNDER ANY REASON.**

**LIABILITIES:** All Taxes / Statutory liabilities shall be the sole responsibility of the exhibitor.

**STALL OCCUPATION:** All exhibitors will occupy their booked booth a day prior to the exhibition till 11.00 am otherwise they will **NOT** be allowed to enter.

\* **PASTING OF VINYL & USE OF BOND ON STALL PANEL IS NOT ALLOWED. Penalty charges of Rupees 1000/- per panel will be levied on the exhibitor .**

\* **THE COST OF PANEL WILL BE BORNE BY THE EXHIBITOR IF PANEL DAMAGES AFTER THE OCCUPANCY OF STALL.**

**GATE PASS:** 1) Exhibitors are requested to note that, they would require a gate pass for security / payment outstanding purpose in case they wish to take any exhibits / items out of the exhibition ground. The Gate Pass will be available on your request from the office

. 2) Final Gate Pass would be needed on the last day for the exhibitor to move out of exhibition ground.
